

Freedom Solar Referral Terms and Conditions

This Affiliate Service Agreement (the "Agreement") is made by and between Freedom Solar, Inc., and you, as an Affiliate individual or group utilizing the freedomsolar.net service(s) ("You", "Your", "Affiliate").

You must agree to abide by the terms and conditions contained in this Agreement in order to participate. Please read this Agreement carefully before submitting referrals. By submitting referrals, you indicate your acceptance of this Agreement and its terms and conditions. If you do not submit referrals, you will not be a part of the affiliate referral program and will not be paid for your referrals.

The following agreement is summarized as follows:

- You must be 18 years of age to participate.
- You must be a U.S. Citizen.
- Freedom Solar may email you concerning any missing or erroneous contact information.
- You will be paid up to a \$500 referral, at such time as your referral's system is installed and operational and logged as such in our sales system. You will be required to fill out a W-9 prior to receiving payment.
- International affiliates (those with addresses outside of the 50 U.S. States) must have a valid social security number.
- Your physical address listed for receiving checks and/or gift cards or restaurant gift cards MUST be your actual address. Mail forwarding services for the purpose of avoiding network demographics is NOT allowed.
- You agree not to hold Freedom Solar liable for anything.
- Each participant will be required to pay taxes on all incentives, commissions, payouts or checks issued by Freedom Solar to you. Freedom Solar will provide you with a W-9 for the current tax year.
- You may not SPAM. Freedom Solar will terminate your account on the first offense of SPAMMING. Do not send email to lists or groups that you do not have permission to send to.
- You may not announce the offer or generate referrals on your own (outside of any efforts made by Freedom Solar), using banners or links within your newsletters, blogs, in content of your website, or within other web related content such as social networking sites like Twitter, Facebook, Myspace and any other non-offensive, non-pornographic and non-hateful sites.
- Duplicate referrals will be handled as follows: The first person that submits the referral,

based on the time stamp in our system, gets credit for the sale and receives the referral. This also applies to referrals that are already logged in our system or are customers of Freedom Solar. Each referral must be generated outside the efforts of Freedom Solar.

- Our system will not accept your referral if you mis-type your email. We are not responsible for any mis-typed information that you provide in your member registration form.
- Failure to abide by these rules could mean termination from the affiliate program with a complete forfeit of payout.

Privacy Policy

Definitions

“Payout” means the amount of sale commission, lead commission, or click commission a Merchant agrees to pay for an individual measurable action. The Payout is defined as either a percentage of a total sale amount, or as a set bounty (flat rate) per action. In this case the payout is up to \$500 for each referral, provided by you, that results in the sale of a solar electric system (residential or commercial).

Affiliate Payment

You will receive a Payout for providing referral leads that result in a signed contract for a solar electric system installation. You will receive the Payout from Freedom Solar. Payments will be made following the installation and commissioning of the solar system.

Service and Support

Freedom Solar will provide support for the Service as indicated on the Freedom Solar web sites and Terms of Service.

Email Contact

Freedom Solar reserves the right to send e-mail to you for the purposes of informing you of applicable changes or additions to the affiliate referral program.

Changes to the Service

Freedom Solar reserves the right to change, modify, add or remove portions of this Agreement at any time and may add to, change, suspend or discontinue any aspect of the Service at any time. In the event of any material change, Freedom Solar will notify you via

e-mail, newsletter or the Freedom Solar web site at least 7 days prior to any such changes taking effect, at which time you may either agree to such changes or withdraw from the Service.

Participation

You must be at least 18 (eighteen) years of age, and supply a valid tax-id, which may be your social security number for individuals, or a federal tax-id for corporations or entities. You will be required to fill out a W-9 prior to receiving payment.

Accepted Use

You represent to Freedom Solar that all content You provide to the Service is solely owned by You or provided by You with the express authority of the person or company You represent, does not infringe upon any other individual's or organization's rights (including, without limitation, intellectual property rights, trademarks or copyrights) and is not defamatory, libelous, unlawful or otherwise objectionable. You shall not provide, promote, distribute, place or otherwise publish as an Affiliate of the Service any content, or Web site that includes content, which is libelous, defamatory, obscene, pornographic, abusive, fraudulent or violates any law. As Freedom Solar may not review all information provided by You, You shall remain solely responsible for your content and Web site. If you are terminated from the Service, Freedom Solar has the right to withhold money you earned within the Service and you will not be allowed to re-join the Freedom Solar affiliate referral program.
